POLICIES

1. The use of Aruba Racquet Club is limited to Aruba Racquet Members Only.
2. Members must check-in at front desk before entering.
3. Children under 12 must be accompanied by a member 16 or older.
4. Access to the GYM is restricted to members 16 and older.
5. Members are entitled to full use of club amenities and have preferred ticket right to all tournaments and events held at the club

GUESTS PRIVILEGES

1. Members of the club are allowed to have guests by paying a guest fee. Please ask for prices in advance.
2. The member is responsible for any damages caused by his/her guest.
3. ARC at its sole discretion, reserves the right to deny guest privileges to anyone who in the past has misbehaved in any way towards the club.
4. Under no circumstances will guest privileges be extended to ex-members.

DRESS CODE, BEHAVIOR & HOUSEKEEPING

1. All members and their guests must conform to the general dress code for hygiene and appearance. The management reserves the right to qualify any member's attire as appropriate and descent in relationship to the public image of the club and its rules.
2. While on club premises, all members shall also observe general rules of conduct. The use of profanity, obscene gestures, discussions on religion / politics etc is strictly prohibited.

COURT RULES

1. Only members and their signed up guests are allowed on the courts.
2. Only members are allowed to take tennis lessons and take part of any activity of the club. Exceptions are made during Open Tournaments.
3. Court reservations should be made ahead of time at the ARC office.
4. Playing on wet tennis courts is strictly prohibited.
5. Players must wear proper tennis attire.
6. Shoes with leather or hard soles are strictly prohibited. Only Tennis Shoes are allowed to be worn while playing on the Tennis Courts.
7. No glass are permitted on courts.
8. Players must remove their cans, cups, plates, napkins, etc from the tennis courts and deposit these in a trashcan.
9. No chewing gum allowed on the courts.
10. Tennis courts are used for playing Tennis only. NO skateboards, bikes, soccer ball etc. allowed on the courts.
11. Singles play is allowed for 60 minutes and Doubles play 90 minutes
12. No reservation in blocks are allowed

7. WAIVER OF LIABILITY
